# President's Draft Negotiating Document for the High-Level Plenary Meeting of the General Assembly of September 2005, submitted by the President of the General Assembly – 6 September 2005

# I. Values and principles

- 1. We, Heads of State and Government, have gathered at United Nations Headquarters in New York from 14 to 16 September 2005.
- 2. We reaffirm our faith in the United Nations and our commitment to the purposes and principles of the Charter and international law, which are indispensable foundations of a more peaceful, prosperous, and just world, and reiterate our determination to foster their strict respect.
- 3. We reaffirm the United Nations Millennium Declaration, which we adopted at the dawn of the twenty-first century. We recognize the valuable role of the major United Nations conferences and summits in the economic, social and related fields, including the Millennium Summit, in mobilizing the international community at the local, national, regional and global levels and in guiding the work of the United Nations, [and we reaffirm their outcomes and renew our commitment to fully implement them in an integrated and coordinated manner].
- 4. We reaffirm that our common fundamental values, including freedom, equality, solidarity, tolerance, respect for all human rights, respect for nature and shared responsibility, are essential to international relations.
- 5. We are determined to establish a just and lasting peace all over the world in accordance with the purposes and principles of the Charter. We rededicate ourselves to support all efforts to uphold the sovereign equality of all States, respect for their territorial integrity and political independence, refrain in our international relations from the threat or use of force in any manner inconsistent with the purposes of the United Nations, resolution of disputes by peaceful means and in conformity with the principles of justice and international law, the right to self-determination of peoples [which remain under colonial domination and foreign occupation], non-interference in the internal affairs of States, respect for human rights and fundamental freedoms, respect for the equal rights of all without distinction as to race, sex, language or religion and international cooperation in solving international problems of an economic, social, cultural or humanitarian character, and fulfilment in good faith of the obligations assumed in accordance with the Charter.
- 6. We reaffirm the vital importance of an effective multilateral system, in accordance with international law, in order to better address the multifaceted and interconnected challenges and threats confronting our world and to achieve progress in the areas of peace and security, development, and human rights, [and commit ourselves to promoting and strengthening the effectiveness of the Organization through the implementation of its decisions and resolutions].
- 7. We believe that today, more than ever before, we live in a global and interdependent world. No State can stand wholly alone. We acknowledge that collective security depends on effective cooperation, in accordance with international law, against transnational threats.
- 8. We recognize that current developments and circumstances require that we urgently build consensus on major threats and challenges. We commit ourselves to translating that

consensus into concrete action, including addressing the root causes of those threats and challenges with resolve and determination.

- 9. We acknowledge that peace and security, development and human rights are the pillars of the United Nations system and the foundations for collective security and well-being. We recognize that development, peace and security and human rights are interlinked and mutually reinforcing.
- 10. We reaffirm that development is a central goal by itself and that sustainable development in its economic, social, and environmental aspects constitutes a key element of the overarching framework of United Nations activities.
- 11. We acknowledge that good governance and the rule of law at the national and international levels are essential for sustained economic growth, sustainable development and the eradication of poverty and hunger.
- 12. We reaffirm that gender equality and the promotion and protection of the full enjoyment of all human rights and fundamental freedoms for all are essential to advance development, peace and security. We are committed to creating a world fit for future generations, which takes into account the best interests of the child.
- 13. We reaffirm the universality, indivisibility, and interdependence of all human rights.
- 14. Acknowledging the diversity of the world, we recognize that all cultures and civilizations contribute to the enrichment of humankind. We acknowledge the importance of respect and understanding for religious and cultural diversity throughout the world. In order to promote international peace and security, we commit ourselves to advancing human welfare, freedom and progress everywhere, as well as to encouraging tolerance, respect, dialogue and cooperation among different cultures, civilizations and peoples.
- 15. We pledge to enhance the relevance, effectiveness, efficiency, accountability and credibility of the UN system [and to provide the Organization with the resources needed to fully implement its mandates]. This is our shared responsibility and interest.
- 16. We therefore resolve to create a more peaceful, prosperous, and democratic world, and to undertake concrete measures [to continue finding ways to implement the outcome of the Millennium Summit and the other major United Nations conferences and summits] in the four following areas:
  - Development
  - Peace and collective security
  - Human rights and the rule of law
  - Strengthening of the United Nations

#### II. Development

- 17. We strongly reiterate our determination to ensure the timely and full realization of the development goals and objectives that emerged from the major United Nations conferences and summits, [including the Millennium Development Goals], which have helped to galvanize efforts towards poverty eradication.
- 18. We emphasize the vital role played by the major United Nations conferences and summits in the economic, social and related fields in shaping a broad development vision

and in identifying commonly agreed objectives, which have contributed to improving human life in different parts of the world.

19. We are encouraged by reductions in poverty in the recent past and are determined to reinforce and extend this trend to benefit people worldwide. We remain concerned, however, with the slow and uneven progress in some regions, particularly in Africa. We underline the need for urgent action on all sides, including more ambitious national development strategies and efforts backed by increased international support. We reaffirm our commitment to eradicate poverty and promote sustained economic growth, sustainable development and global prosperity for all. We commit ourselves to promote the development of the productive sectors in developing countries to enable them to participate more effectively in, and benefit from, the process of globalization.

#### Global partnership for development

- 20. We reaffirm our commitment to the global partnership for development in the Millennium Declaration, the Monterrey Consensus and the Johannesburg Plan of Implementation.
- 21. We further reaffirm our commitment to sound policies, good governance at all levels and the rule of law, and to mobilizing domestic resources, attracting international flows, promoting international trade as an engine for development, increasing international financial and technical cooperation for development, sustainable debt financing and external debt relief, and enhancing the coherence and consistency of the international monetary, financial and trading systems.
- 22. We reaffirm that each country must take primary responsibility for its own development and that the role of national policies and development strategies cannot be overemphasized. We also recognize that national efforts should be complemented by supportive global programmes, measures and policies aimed at expanding the development opportunities of developing countries, while taking into account national conditions and ensuring respect for national ownership, strategies and sovereignty. To this end, we resolve to:
- a) Adopt, by 2006, and begin to implement comprehensive national development strategies to achieve the internationally agreed development goals and objectives, [including the Millennium Development Goals] by 2015;
- b) Manage public finances effectively to achieve and maintain macroeconomic stability and long-term growth and to make effective and transparent use of public funds and ensure that development assistance is used to build national capacities;
- c) Pursue good governance and sound macro-economic policies [at the national and international levels] [at all levels] and support developing countries in their efforts to put in place the policies and investments to drive sustained economic growth, promote small and medium-sized enterprises, promote employment generation and stimulate the private sector;
- d) [Reaffirm that good governance is essential for sustainable development; sound economic policies, solid democratic institutions responsive to the needs of the people and improved infrastructure are the basis for sustained economic growth, poverty eradication and employment creation; and that] freedom, peace and

security, domestic stability, respect for human rights, including the right to development, the rule of law, gender equality, market-oriented policies and an overall commitment to just and democratic societies [are also essential and mutually reinforcing];

- e) Make the fight against corruption a priority [at all levels], and welcome all actions taken in this regard at the national and international levels, including the adoption of policies that emphasize accountability, transparent public sector management [transparent corporate sector management] [competitive markets] [transparent public sector and corporate responsibility], and corporate responsibility and accountability. We urge all States that have not done so to [consider to] sign, ratify and implement the United Nations Convention Against Corruption;
- f) Support efforts by developing countries to adopt and implement national development policies and strategies, through increased development assistance, promotion of international trade as an engine for development, transfer of technology on mutually agreed terms, increased investment flows and wider and deeper debt relief; and support developing countries by providing a substantial increase in aid of sufficient quality and arriving in a timely manner to assist them in achieving the internationally agreed development goals, [including the Millennium Development Goals];
- g) [Recognize it is particularly important for developing countries, bearing in mind development goals and objectives, that all countries take into account the need for appropriate balance between national policy space and international disciplines and commitments];
- h) Enhance the contribution of non-governmental organizations, civil society, the private sector and other stakeholders in national development efforts, as well as in the promotion of the global partnership for development;
- i) Ensure that United Nations funds, programmes and the specialized agencies support the efforts of developing countries through the common country assessment and United Nations Development Assistance Framework process, enhancing their support for capacity building;
- j) Protect our natural resource base in support of development.

# Financing for development

- 23. We reaffirm the Monterrey Consensus and recognize that mobilizing financial resources for development and the effective use of those resources in developing countries and countries with economies in transition are central to a global partnership for development in support of the achievement of the internationally agreed development goals, **[including the Millennium Development Goals].** In this regard:
- a) [We are encouraged by the [substantial] increase in official development assistance since the Millennium Summit and by [recent commitments] in this regard, [while recognizing that a further substantial increase in ODA is needed if developing countries are to achieve the internationally agreed development goals, including those contained in the Millennium Declaration];
- [a) alt We are encouraged by recent commitments to substantial increases in official development assistance, [and the OECD estimate that ODA to all developing

countries will now increase by around US\$50 billion a year by 2010], while recognizing that a substantial increase in such assistance is required to achieve the internationally agreed goals, including, by 2015, the Millennium Development Goals;

- b) [In that context we urge developed countries that have not done so to make concrete efforts towards the target of 0.7% of GNP as ODA to developing countries and 0.15 to 0.20 to Least Developed Countries;]
- c) [We welcome the establishment of timetables by many developed countries to achieve the target of 0.7 per cent of GNP for ODA by no later than 2015 and to reach at least 0.50 per cent by 2010, urge those developed countries that have not yet done so to make concrete efforts in this regard and invite them to establish timetables in order to achieve the target of 0.7 per cent;]
- d) We further welcome recent efforts and initiatives to enhance the quality of aid and to increase its impact, including the Paris Declaration on Aid Effectiveness, and resolve to take concrete, effective and timely action in implementing all agreed commitments on aid effectiveness, with clear monitoring and deadlines, including through further aligning assistance with countries' strategies, building institutional capacities, reducing transaction costs and eliminating bureaucratic procedures, making progress on untying aid, enhancing the absorptive capacity and financial management of recipient countries and strengthening the focus on development results;
- (e) [We recognize the need for increased resources as well as resource predictability, and in that regard take note with interest of international efforts, contributions and discussions, such as the Action against Hunger and Poverty, aimed at identifying innovative and additional sources of financing for development on a public, private, domestic or external basis and complementary to official development assistance. [We also welcome the pilot projects, to be implemented on a voluntary basis, for an international finance facility for immunization and a solidarity contribution from plane tickets to finance development projects, in particular in the health sector, including the fight against HIV/AIDS and other pandemics, and agree to consider further other solidarity contributions that would be nationally applied and internationally coordinated. We underline the need for increased investment now, and further recognize the potential benefits offered by the front-loading of additional official development assistance commitments.] OR [Some of us will continue to consider the International Financing Facility (IFF), a pilot IFF for immunization and a solidarity contribution on plane tickets to finance development projects, in particular, in the health sector and to finance the IFF.];]
- **(f)** We acknowledge the vital role the private sector can play in generating new investments, employment and financing for development;

- (g) [We resolve to undertake measures to address the development needs of lowincome developing countries by agreeing in competent multilateral and international fora, to help them meet, inter alia, their financial, technical and technological requirements;]
- (h) [We resolve to continue to support the development efforts of middle-income developing countries by agreeing, in competent multilateral and international

forums and also through bilateral arrangements, on measures to help them meet, *inter alia*, their financial, technical and technological requirements;]

(i) We resolve to operationalize the World Solidarity Fund established by the General Assembly and invite those countries in a position to do so to make voluntary contributions to the Fund.

#### **Domestic Resource Mobilization**

24. We stress the need to maximize the use of domestic resources for development and recognize the need for access to financial services, in particular for the poorest, including through microfinance and microcredit.

- [25. In our common pursuit of growth, poverty eradication and sustainable development, a critical challenge is to ensure the necessary internal conditions for mobilizing domestic saving, both public and private, sustaining adequate levels of productive investment and increasing human capacity. We therefore resolve to:
- i. Promote macroeconomic policies that promote sustainable development; implement transparent, predictable and credible government economic policies; promote sound public finance management and fight corruption and money laundering;
- ii. Implement the necessary policy frameworks to promote market efficiency, control wasteful spending, consolidate democracy and encourage private financial flows;
- iii. Strengthen, where necessary and appropriate, property rights and expand the use of property as collateral, ensuring enforceable, efficient, transparent, comprehensive, and equitable rules governing property contracts, and improve or promote the related measures governing the transfer of property, property registries, the use of property as collateral, and the rights and responsibilities of debtors and creditors:
- iv. Channel private capabilities and resources into stimulating the private sector in developing countries through actions in the public, public/private and private spheres to create an enabling environment for partnership and innovation that contributes to accelerated economic development and hunger and poverty eradication;
- v. To promote and facilitate national policy dialogue on the role of the indigenous private sector in development, and induce policy, legal and regulatory frameworks to support private sector development.]

#### Investment

26. We resolve to encourage direct investment in developing countries and countries with economies in transition to support their development activities and to enhance the benefits they can derive from such investments. In this regard, we:

- a) Continue to support efforts to create a conducive domestic environment for attracting investments by developing countries and countries with economies in transition *inter alia*, achieving a transparent, stable and predictable investment climate with proper contract enforcement and respect for property rights and the rule of law, and pursuing appropriate policy and regulatory frameworks that encourage business formation;
- b) Put into place policies to ensure adequate investment in a sustainable manner in health, clean water and sanitation, housing and education, and the provision of public goods and social safety nets to protect vulnerable and disadvantaged sections of society; [Question of placement.]
- c) Invite national Governments seeking to develop infrastructure projects and generate foreign direct investments to pursue strategies with the involvement of both public and private sectors and where appropriate, international donors;
- d) [Call upon international financial and banking institutions to consider streamlining and enhancing the transparency of risk rating mechanisms with a view to making them more development-oriented;]
- [d) alt Call upon international financial and banking institutions to consider enhancing the transparency of risk rating mechanisms. Sovereign risk assessment made by the private sector should maximize the use of strict, objective and transparent parameters, which can be facilitated by high quality data and analysis;
- e) [Urge initiation] [Invite consideration of] measures that mitigate the impact of excessive volatility of short-term capital flows;
- f) We commit ourselves to undertaking measures to promote stable international capital flows to developing countries, particularly [countries in Africa, the least developed countries, small island developing States and landlocked developing countries], and to countries with economies in transition.

#### Debt

- 27. Debt can be an important source of capital for development. Debt sustainability is essential for underpinning growth. We emphasize the urgent need for an effective, comprehensive, durable [and development-oriented] solution to the debt problems of developing countries. To this end we:
- a) Welcome the recent proposals of the Group of Eight (G8) to cancel 100 per cent of the outstanding debt of eligible Heavily Indebted Poor Countries owed to the International Monetary Fund, the International Development Association and African Development Fund and to provide additional resources to ensure that the financing capacity of the international financial institutions is not reduced;
- b) [Stress that debt sustainability is critical to the achievement of national development goals, including the Millennium Development Goals], recognizing the key role that debt relief can play in liberating resources that can then be directed towards activities consistent with attaining sustainable growth and development;
- c) [Further stress the need to consider additional measures and initiatives aimed at ensuring long-term debt sustainability through increased grant-based financing, cancellation of 100 per cent of the official multilateral and bilateral debt of heavily indebted poor countries and, on a case-by-case basis, significant reduction or cancellation of debt for developing countries with an unsustainable debt burden,

such as heavily indebted least developed countries that are not part of the Heavily Indebted Poor Countries Initiative, as well as of low- and middle-income developing countries. Such initiatives should include efforts by the International Monetary Fund and the World Bank to develop and implement a debt sustainability framework for low-income countries. This should be achieved without reducing ODA transfers to low-income countries or reducing resources channelled as official development assistance as well as other sources of financing available to other developing countries, while maintaining the financial integrity of the multilateral financial institutions.

#### **Trade**

- 28. We recommit ourselves to the promotion of a universal, rules-based, open, non-discriminatory and equitable multilateral trading system, recognizing the major role that trade can play in promoting economic growth, employment and development for all, and are resolved to:
- a) Achieve the fullest realization of the Doha work programme, including the development mandate of the Doha Ministerial Declaration, in particular in the areas identified in the 1 August 2004 decision of the General Council of the World Trade Organization, [such as agriculture, cotton, non-agricultural market access, services, rules, including trade facilitation, the Agreement on Trade-Related Aspects of Intellectual Property Rights, trade and environment and development, including special and differential treatment], and to successfully complete, by 2006, the World Trade Organization Doha round of multilateral trade negotiations;
- b) Provide in accordance with the Brussels Programme of Action [immediate] duty-free and quota-free market access for [all] LDC products to the markets of developed countries, as well as to the markets of developing countries in a position to do so, and support their efforts to overcome their supply-side constraints as well as volatile commodity prices and terms of trade;
- c) Support and promote increased aid to build productive and trade capacities of developing countries and take further steps in that regard, while welcoming the substantial support already provided;
- d) Work to accelerate and facilitate the accession of developing countries and countries with economies in transition to the World Trade Organization [consistent with its criteria], recognizing the importance of [universal] integration in the rules-based global trading system;
- [d) bis The particular problems of small, vulnerable developing economies, including small island developing States and landlocked developing countries within a new global framework for transit transport cooperation for landlocked and transit developing countries, should be given special consideration and the examination of issues relating to the trade of small, vulnerable economies, and the framing of responses to these trade-related issues to facilitate their fuller integration into the multilateral trading system should be actively pursued consistent with the Doha Work Programme;]

[d) ter. Achieve the fullest realization of the development mandate of the Doha Ministerial Declaration and the WTO General Council decision of 1 August 2004 including substantial reduction of trade-distorting domestic support and elimination of export subsidies by developed countries as well as a strong special and differential treatment component in the final outcome of negotiations on agriculture, NAMA and services and successful resolution of the outstanding implementation issues; and expeditiously and successfully complete, preferably by 2006, the WTO Doha Round of multilateral trade negotiations;

Find an expeditious, permanent and multilateral solution to the difficulties faced by WTO Members with insufficient or no manufacturing capacities in the pharmaceutical sector, in making effective use of compulsory licensing under the TRIPS Agreement, as provided in paragraph 6 of the Declaration on TRIPS Agreement and Public Health, adopted on 14 November 2001;

Ensure that the comparative advantage of developing countries is not undermined by forms of protectionism including the arbitrary and abusive use of non-trade barriers and other standards to unfairly restrict access of developing countries' products into developed countries' markets, and reaffirm that developing countries should play an increase role in the formulation of, *inter alia*, safety, environmental and health standards;

Emphasize that enhanced market access for goods and services of export interest to developing countries to the markets of developed countries, as well as special and differential treatment for the developing countries, balanced rules and well-targeted sustainably financed technical assistance and capacity-building programmes for developing countries are needed for the realization of the development dimension highlighted in the Doha work Programme;

Emphasize the need to provide an immediate solution to the question of commodities, and in this context, stress the need for a more effective international arrangement to address the problems of weak and volatile commodity prices, which pose a serious constraint to sustained development in many developing countries;

Work expeditiously towards integrating the development dimensions in the rule making in the intellectual property regime to make it development oriented and to facilitate the transfer of technology and knowledge to developing countries, as well as to work towards a legally binding international instrument on the preservation, protection and promotion of traditional knowledge and genetic resources;

Call for accelerating the negotiations on the development-related mandate concerning the TRIPS Agreement in the Doha Ministerial Declaration, especially the amendments of TRIPS Agreement in order for intellectual property rules to fully support the objectives of the convention on Biological Diversity as well as trade-related aspects of Intellectual Property Rights and Public Health to address the problems afflicting many developing countries including least developed countries, especially those resulting from HIV/AIDS, tuberculosis, malaria and other epidemics.]

#### **Commodities**

29. Emphasize the need to address the impact of weak and volatile commodity prices and support the efforts of commodity-dependent countries to restructure, diversify and strengthen the competitiveness of their commodity sectors.

#### [Quick-win initiatives]

30. [We agree to support the establishment and implementation of country-led "quickwin" initiatives consistent with long-term national development strategies so as to realize [major immediate] progress towards the development goals, including the Millennium Development Goals, through such measures as the distribution of [free] malaria bed nets and effective anti-malarial medicines, the expansion of local school meal programmes using home-grown foods and the elimination of user fees for primary education and health services.]

# Global governance and systemic issues

- 31. We reaffirm the commitment to broaden and strengthen [the voice and] participation of developing countries and countries with economies in transition in international economic decision-making and norm-setting, and to that end stress the importance of [advancing] [sustaining] efforts to reform the international financial architecture, [and resolve to find pragmatic and innovative ways to enhance the effective participation of those countries therein, particularly in the Bretton Woods institutions].
- 32. We reaffirm our commitment to **[good governance,]** equity and transparency in the financial, monetary and trading systems. We are also committed to open, equitable, rule-based, predictable and non-discriminatory multilateral trading and financial systems.
- 32.bis [We also underscore our commitment to sound domestic financial sectors, which make a vital contribution to national development efforts, as an important component of an international financial architecture that is supportive of development.]
- 33. We further reaffirm the need for the United Nations to play a leadership role in **[promoting development] [international development policy]** and in ensuring coherence, coordination and implementation of development goals and actions agreed upon by the international community, and we resolve to strengthen coordination within the United Nations system in close cooperation with all other multilateral financial trade and development institutions in order to support sustained economic growth, poverty eradication and sustainable development.
- 33. bis. [We reaffirm the need to take steps with a view to avoidance of, and refraining from, any unilateral measure not in accordance with international law and the Charter of the UN that impedes the full achievement of economic and social development by the population of the affected countries, in particular women and children, that hinders their well-being or that creates obstacles to the full enjoyment of their human rights, including the right of everyone to a standard of living adequate for their health and well-being and their right to food, medicinal care and the necessity of social services, and to ensure that food and medicine are not used as tools for political pressure.]

# **South-South cooperation**

34. We recognize the achievements and great potential of South-South cooperation and encourage the promotion of such cooperation, which complements North-South cooperation as an effective contribution to development and as a means to share best practices and transfer technologies [on mutually agreed terms]. In this context, we [welcome] [note] the recent decision of the leaders of the South, adopted at the Second South Summit and contained in the Doha Plan of Action and the Doha Declaration, to intensify their efforts at South-South cooperation, including through the establishment of the New Asian-African Strategic Partnership and other regional cooperation mechanisms, and [reiterate the need for] [encourage] the international community, [including the international financial institutions], to support [as appropriate] the efforts of developing countries, inter alia, through the provision of the necessary resources, as well as through triangular cooperation

[alt. reiterate the value of support by the international community including through triangular cooperation for the efforts of developing countries. We also welcome the launching of the third round of the GSTP as an important instrument to stimulate South-South cooperation.]

- 35. We welcome the work of the High Level Committee of the United Nations on South-South cooperation and [stress the need to support] [invite countries to consider supporting] the Special Unit for South-South Cooperation within UNDP, in order to respond effectively to the development needs of developing countries.
- 36. We recognize the considerable contribution of arrangements such as the OPEC fund initiated by a group of developing countries, as well as the potential contribution of the South Fund for Development and Humanitarian Assistance, to development activities in developing countries.

#### **Education**

- 37. We emphasize the critical role of both formal and informal education in the achievement of poverty eradication and other development goals as envisaged in the Millennium Declaration, in particular basic education and training for eradicating illiteracy, and strive for expanded secondary and higher education as well as vocational education and technical training, especially for girls and women, the creation of human resources and infrastructure capabilities and the empowerment of those living in poverty. In this context, we reaffirm the Dakar Framework for Action adopted at the World Education Forum in 2000 and recognize the importance of the United Nations Educational, Scientific and Cultural Organization strategy for the eradication of poverty, especially extreme poverty, in supporting the Education for All programmes as a tool to achieve the goal of universal primary education by 2015.
- 38. We reaffirm our commitment to support developing country efforts to ensure that all children have access to, and complete free and compulsory primary education of good quality; to eliminate gender inequality and imbalance; and to renew efforts to improve girls education. We also commit ourselves to supporting the efforts of developing countries in the implementation of the Education for All initiative, [including through channelling bilateral and multilateral resources through the Education for All Fast-Track Initiative in support of country-led national education plans.]
- 39. We commit to promote education for peace and human development.

# Rural and agricultural development

40. We reaffirm that food security and rural and agricultural development must be adequately and urgently addressed in the context of national development and response strategies and in this context, will enhance the contributions of indigenous and local communities, as appropriate. We are convinced that the eradication of poverty, hunger and malnutrition, particularly as they affect children, is crucial for the achievement of [the Millennium Development Goals]. Rural and agricultural development should be an integral part of national and international development policies. We deem it necessary to increase productive investment in rural and agricultural development to achieve food security. We commit ourselves to [support] [increase ODA for] agricultural development and trade [opportunities] [capacity building in the agricultural sector for] in developing countries [through the elimination of all agricultural export subsidies]. [We support the Common Fund for Commodities, particularly its Second Account.]

#### **Employment**

41. We strongly support fair globalization and resolve to make the goals of full and productive employment and decent work for all, including for women and young people, a central objective of our **[national and international]** policies as well as national development strategies, including poverty reduction strategies, as part of our efforts to achieve **[the Millennium Development Goals.]** These measures should also encompass the elimination of the worst forms of child labour, as defined in the ILO Convention No.182, and forced labour. We also resolve to ensure full respect for the Fundamental Principles and Rights at Work.

# [Sustainable development: managing and protecting our common environment]

42. [We reaffirm our commitment to achieve the goal of sustainable development, including through the implementation of Agenda 21 and the Johannesburg Plan of Implementation. To this end, we commit ourselves to undertaking concrete actions and measures at all levels and to enhancing international cooperation, taking into account the Rio principles, [including, inter alia, the principle of common but differentiated responsibilities as set out in Principle 7 of the Rio Declaration on Environment and Development.] These efforts will also promote the integration of the three components of sustainable development — economic development, social development and environmental protection — as interdependent and mutually reinforcing pillars. Poverty eradication, changing unsustainable patterns of production and consumption and protecting and managing the natural resource base of economic and social development are overarching objectives of, and essential requirements for, sustainable development. [We recognize that climate change is a serious and long term challenge that has the potential to affect every part of the world and that human activities are contributing in large part to increases in greenhouse gases associated with the warming of our Earth's surface.] [We will act with resolve and urgency now to meet our shared and multiple objectives of reducing greenhouse gas emissions, improving the global environment, enhancing energy security and cutting air pollution in conjunction with our vigorous efforts to reduce poverty. We reaffirm our commitment to the UNFCCC and to its ultimate

objective to stabilize greenhouse gas concentration in the atmosphere at a level that prevents dangerous interference with the climate system.] We therefore resolve to:]

- a) Promote sustainable consumption and production patterns, as called for in the Johannesburg Plan of Implementation, paragraph 14 [with developed countries taking the lead];
- b) [Undertake [urgent and] concerted global action to [address] [mitigate] climate change, including by meeting all commitments and obligations under the Kyoto Protocol, the United Nations Framework Convention on Climate Change and other relevant international agreements; increase energy efficiency [, the use of renewable] and technological innovation; and initiate negotiations to develop a more [inclusive] [effective] international framework for climate change beyond 2012 [to stabilize concentration of greenhouse gases], with broader participation by both developing and developed countries [and all relevant emitters], taking into account the principle of common but differentiated responsibilities;]
- [b)bis Act with resolve and urgency to meet our shared and multiple objectives of reducing greenhouse gas emissions, improving the global environment, enhancing energy security and reducing air pollution in conjunction with our vigorous efforts to reduce poverty;
- b)ter Promote innovation, energy efficiency, conservation; improve policy, regulatory and financing frameworks; and accelerate deployment of cleaner technologies, particularly lower emitting technologies;
- b)quat Work with developing countries to enhance private investment and transfer of technologies, taking into account their own energy needs, and help them build capacity to improve their resilience and integrate adaptation goals into sustainable development strategies];
- c) Promote the UN Decade of Education for Sustainable Development and the International Decade of Water for Life;
- d) Continue to assist developing countries, in particular [small island developing States, least developed countries and African countries] [including those that are particularly vulnerable to climate change] in addressing their adaptation needs relating to the adverse effects of climate change;
- e) Support and strengthen the implementation of the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, Particularly in Africa to address causes of desertification and land degradation, and poverty resulting from land degradation [through, *inter alia*, the mobilization of adequate and predictable financial resources, transfer of technology and capacity building at all levels];

- f) Support the implementation [by the Parties to] the Convention on Biological Diversity and its Cartagena Protocol on Biosafety, as well as other biodiversity-related agreements such as [CITES, Ramsar and] the Johannesburg commitment for a significant reduction in the rate of loss of biodiversity by 2010, [and negotiate within the framework of the Convention on Biological Diversity, bearing in mind the Bonn Guidelines, an international regime to promote and safeguard the fair and equitable sharing of benefits arising out of the utilization of genetic resources [Fulfill commitments and significantly reduce the rate of loss of biodiversity by 2010 and continue ongoing efforts towards elaborating and negotiating on an international regime on access to genetic resources and benefit-sharing];
- g) Recognize that the sustainable development of indigenous peoples and their communities is crucial in our fight against hunger and poverty;
- h) Reaffirm our commitment, subject to national legislation, to respect, preserve and maintain knowledge, innovations and practices of indigenous and local communities embodying traditional lifestyles relevant to the conservation and sustainable use of biological diversity, promote their wider application with the approval and involvement of the holders of such knowledge, innovations and practices and encourage the equitable sharing of the benefits arising from their utilization;
- i) Work urgently towards the establishment [by 2006] of a worldwide early warning system for all natural hazards, with regional nodes, building on existing national and regional capacity such as the newly established Indian Ocean Tsunami Warning and Mitigation System;
- j) Fully implement the Hyogo Declaration and the Hyogo Framework for Action 2005-2015, adopted at the World Conference on Disaster Reduction, in particular those commitments related to assistance to developing countries that are prone to natural disasters and disaster stricken States in the transition phase towards sustainable physical, social and economic recovery, for risk reduction activities in post-disaster recovery and rehabilitation processes;
- k) Assist developing countries' efforts to provide access to safe drinking water and basic sanitation for all in accordance with the Millennium Declaration and the Johannesburg Plan of Implementation, accelerate the preparation of integrated water resources management and water-efficiency plans and support related efforts by developing countries that are part of their national development strategies to halve by 2015 the proportion of access to people to safe drinking and improved sanitation;
- 1) Improve access to reliable, affordable, economically viable and environmentally sound energy services, resources and technologies, in particular to developing countries on favourable terms, including on concessional and preferential terms, as mutually agreed;
- m) Strengthen the sustainable management [and conservation and sustainable development] of all types of forests for the benefit of current and future generations, [including through integrated approaches], enhanced international cooperation [at all levels] and [appropriate international arrangements], so that forests can contribute fully to the achievement of the internationally agreed development goals, including those contained in the Millennium Declaration, and sustainable forest management is implemented [at all levels] [nationally and globally], taking full account of the linkages between the forest sector and other sectors [supporting the UN Forum on Forests];

- n) Promote the sound management of chemical and hazardous wastes throughout their life cycle, aiming to achieve that by 2020 chemicals are used and produced in ways that lead to the minimization of significant adverse effects on human health and the environment using transparent and science-based risk assessment procedures by adopting and implementing a strategic approach to international chemicals management and support developing countries in strengthening their capacities for the sound management of chemicals and hazardous wastes by providing technical and financial assistance;
- o) Improve cooperation and coordination at all levels in order to address issues related to oceans and seas in an integrated manner and promote integrated management and sustainable development of the oceans and seas;
- p) Achieve significant improvement in the lives of at least 100 million slum-dwellers by 2020, recognizing the urgent need for the provision of increased resources for affordable housing and housing-related infrastructure, prioritizing slum prevention and slum upgrading, and encourage support to the United Nations Human Settlements Foundation and its Slum Upgrading Facility;
- q) Support multilateral initiatives and agencies in the field of sustainable development and commit to a successful replenishment of the Global Environment Facility [in 2006] [this year] [along with the successful conclusion of all outstanding reform commitments from the third replenishment];
- [r) Urge States involved in the transport of radioactive materials by sea through the regions of small island developing States to continue to engage in dialogue with those and other coastal States so as to address their concerns, particularly those related to further development and strengthening, within the appropriate forums, of international regulatory regimes to enhance safety, disclosure, liability, security and compensation in relation to such transport] {Moved from Section III.}

#### HIV/AIDS, Malaria, Tuberculosis and other health issues

- 43. We recognize that HIV/AIDS, malaria, tuberculosis and other infectious diseases pose severe risks for the entire world and serious challenges to the achievement of development goals. These diseases and other emerging health challenges require a concerted international response. To this end, we commit ourselves to:
- a) Increase investment, building on existing mechanisms and through partnership, to improve health systems in developing countries and those with economies in transition, with the aim of providing [by 2010] sufficient health workers, infrastructure, management systems and supplies to achieve the health-related [Millennium Development Goals] by 2015;
- b) Implement measures to increase capacities of adults and adolescents to protect themselves from the risk of HIV infection [principally through the provision of health care and health services, including for sexual and reproductive health and through prevention education that promotes gender equality within a culture- and gender-sensitive framework];

- c) Ensure that [the resources needed] [as close as possible to universal access] for prevention, treatment, care and support is provided by 2010, to ensure the elimination of stigma and discrimination, as well as enhanced access to affordable medicines, and the reduction of vulnerability of persons affected by HIV/AIDS and other health issues, in particular orphaned and vulnerable children and older persons, through an expanded and comprehensive response to HIV/AIDS and the full funding of the Global Fund to Fight AIDS, Tuberculosis and Malaria, as well as of the United Nations system agencies and programmes engaged in the fight against HIV/AIDS.
- d) Fully implement all commitments established by the Declaration of Commitment on HIV/AIDS through stronger leadership, scaling up a comprehensive response to achieve broad multisectoral coverage for prevention, care, treatment and support, [and mobilizing additional resources from national, bilateral, multilateral and private sources, including increased funding for the Global Fund to fight AIDS, Tuberculosis and Malaria];
- e) Ensure the full implementation of [our obligations under] the International Health Regulations adopted by the 58th World Health Assembly in May 2005, [and emphasize the need to support the Global Outbreak Alert and Response Network of the World Health Organization];
- f) Actively work to implement the "Three Ones" principles in all countries, including by ensuring that multiple institutions and international partners all work under one agreed HIV/AIDS framework that provides the basis for coordinating the work of all partners; with one national AIDS coordinating authority with a broad-based multi-sectoral mandate; and under one agreed country-level monitoring and evaluation (M&E) system. We [will implement] [take note of] the recommendations of the Global Task Team;
- g) Achieve universal access to reproductive health by 2015, as set out at the International Conference on Population and Development, integrating this goal in strategies to attain the internationally agreed development goals, including those contained in the Millennium Declaration aimed at improving maternal health, reducing child mortality, promoting gender equality, combating HIV/AIDS and eradicating poverty;
- h) [Promote] [Encourage] long-term funding, [including public-private partnerships where appropriate] for academic and industrial research, as well as for the development of new vaccines and microbicides, diagnostic kits, drugs and treatments to address major pandemics, tropical diseases and other diseases such as Avian flu and SARS. [We will take forward work on market incentives through such mechanisms as Public Private Partnerships and Advance Purchase Commitments.]
- i) Decide to consider at the 2006 General Assembly Special Session on HIV/AIDS a comprehensive agenda towards the aim of [as close as possible to] universal access to treatment for all those who need it by 2010;
- [(i) bis Welcome the scaling up of bilateral and multilateral anti-malarial and anti-TB initiatives to help developing countries, particularly in Sub-Saharan Africa, reduce the burden of malaria and TB on their people and economies.]

#### Gender equality and empowerment of women

44. We [reaffirm] [remain convinced] that the full and effective implementation of [the goals and objectives of] the Beijing Declaration and Platform for Action and the outcome of

the 23<sup>rd</sup> Special Session of the General Assembly is essential to achieving the internationally agreed development goals, including those contained in the Millennium Declaration, and resolve to promote gender equality and eliminate pervasive gender discrimination by:

- a) Eliminating gender inequalities in primary and secondary education by the earliest possible date and at all educational levels by 2015;
- b) Guaranteeing the free and equal right of women to own and inherit property, and ensuring secure tenure of property and housing by women;
- c) Ensuring equal access to [sexual] reproductive health [and rights];
- d) Promoting women's equal access to labour markets, sustainable employment, and adequate labour protection;
- e) Ensuring equal access of women to productive assets and resources, including land, credit and technology;
- f) Eliminating all forms of discrimination and violence against women and the girl child [including by ending impunity and by] ensuring the protection of civilians, in particular women and the girl child during and after armed conflicts in accordance with the obligations of States under international humanitarian law and [international] human rights law;
- g) Promoting equal [participation of] [opportunity for] men and women [to participate] in government decision-making bodies.
- 45. We recognize the importance of gender mainstreaming as a tool for achieving gender equality. To that end, we undertake to actively promote the mainstreaming of a gender perspective in the design, implementation, monitoring and evaluation of policies and programmes in all political, economic and social spheres, and further undertake to strengthen the capabilities of the United Nations system in the area of gender.

#### Science and technology for development

- 46. We recognize that science and technology, including ICT, are vital for the achievement of the development goals and that international support can help developing countries to benefit from technological advancements and enhance their productive capacity. We therefore commit to:
- a) Strengthen and enhance existing mechanisms and consider **[new]** initiatives to support research and development, including through voluntary partnerships between the public and private sector, to address the special needs of developing countries in the areas of health, agriculture, conservation, sustainable use of natural resources and environmental management, energy, forestry and the impact of climate change;
- b) Promote and facilitate, [as appropriate,] access to and the development, transfer and diffusion of technologies, including environmentally sound technologies and corresponding know-how, to developing countries;

- Assist developing countries in their efforts to promote and develop national strategies for human resources and science and technology, which are primary drivers of national capacity building for development;
- d) Promote and support greater efforts to develop renewable sources of energy, such as solar, wind and geothermal [and ensure the provision of adequate and reliable international financing for such activities];
- e) Implement policies at the national and international levels to attract both public and private investment, domestic and foreign, that enhances knowledge, transfers technology on mutually agreed terms and raises productivity;
- f)Support the efforts of developing countries, individually and collectively, to harness new agricultural technologies in order to increase agricultural productivity through environmentally sustainable means;
- g) Build a people-centred and inclusive information society so as to enhance digital opportunities for all people in order to help bridge the digital divide, put the potential of information and communication technologies at the service of development and address new challenges of the information society by implementing the outcomes of the Geneva phase of the World Summit on the Information Society and by ensuring the success of the second phase of the Summit, to be held in Tunis in November 2005;
- h) In this regard, welcome the establishment of the Digital Solidarity Fund and encourage voluntary contribution to its financing.

# Migration and development

- 47. [We acknowledge the important nexus between international migration and development and the need to deal with this issue in a coordinated and coherent manner with a view to addressing the challenges and opportunities that migration presents to countries of origin, destination and transit. We recognize that international migration brings benefits as well as challenges to the global community. In this regard, we resolve to ensure the success of the General Assembly's high-level dialogue on international migration and development to be held in 2006, which will offer an opportunity to discuss the multidimensional aspects of international migration and development in order to identify appropriate ways and means to maximize their development benefits and address their challenges.]
- 48. We reaffirm our commitment to take measures to ensure respect for and protection of the human rights of migrants, migrant workers and members of their families.
- 49. We reaffirm the need to adopt policies and undertake measures to reduce the cost of transfer of migrant remittances to developing countries, and welcome efforts by Governments and stakeholders in this regard.

# Countries with special needs

- 50. We reaffirm our commitment to address the special needs of the least developed countries and urge the international community and all relevant organizations of the United Nations system, including the Bretton Woods institutions, to make concerted efforts and adopt speedy measures for meeting in a timely manner the goals and targets of the Brussels Programme of Action for the Least Developed Countries for the Decade 2001-2010.
- 51. We recognize the special needs of and challenges faced by landlocked developing countries and therefore reaffirm our commitment to urgently address those needs and challenges through the full, timely and effective implementation of the Almaty Programme of Action and the São Paulo Consensus adopted at the eleventh session of the United Nations Conference on Trade and Development [Such implementation should be quantified with a time-bound set of indicators to measure the progress.]
- 52. We recognize the special needs and vulnerabilities of small island developing States and reaffirm our commitment to take urgent and concrete action to address those needs and vulnerabilities through the full and effective implementation of the Mauritius Strategy adopted by the International Meeting to Review the Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, the Barbados Programme of Action and the outcome of the twenty-second special session of the General Assembly. We further undertake, starting in 2006, to promote greater international cooperation for the implementation of the Mauritius Strategy [through the mobilization of financial resources on a more predictable basis].
- 53. We also emphasize the need for continued, coordinated and effective international support for achieving the development goals in countries emerging from conflict and in those recovering from natural disasters.
- [(53)bis We reaffirm our commitment to work towards the realisation of the right to self-determination of peoples living under colonial or other forms of alien domination or foreign occupation which adversely affects their social and economic development, and to take all necessary measures to bring an end to the continuation of foreign occupation, in accordance with the purposes and principles of the UN Charter and international law.]

# Meeting the special needs of Africa

54. We welcome the [substantial] [important] progress made by the African countries in fulfilling their commitments in the implementation of the NEPAD to promote sustainable growth and development and deepen democracy, human rights, good governance and sound economic management and gender equality, and encourage African countries, with the participation of civil society and the private sector, to continue their efforts in this regard by developing and strengthening institutions for governance and the development of the region, and also welcome the recent decisions taken by Africa's partners, including the Group of Eight (G8) countries and the European Union, in support of Africa's development efforts, including commitments which will lead to an increase in ODA to Africa of US\$25 billion per year by 2010. We reaffirm our commitment to address the special needs of Africa, which is the only continent not on track to meet any of the goals of the Millennium Declaration by 2015, to enable it to enter the mainstream of the world economy, and resolve to:

- a) Strengthen cooperation with the NEPAD by providing coherent support for the programmes drawn up by African leaders within that framework, including by mobilizing internal and external financial resources and facilitating approval of such programmes by the multilateral financial institutions;
- b) Support the African commitment to ensure that by 2015 all children have access to complete, free and compulsory primary education of good quality, as well as to basic health care;
- c) Support the building of an international infrastructure consortium, involving the African Union, the World Bank and the African Development Bank with the New Partnership for Africa's Development as the main framework, to facilitate public and private infrastructure investment in Africa:
- d) Promote a comprehensive and durable solution to the external debt problems of African countries, including through the cancellation of 100 per cent of multilateral debt consistent with the recent G8 proposal for the Heavily Indebted Poor Countries Initiative [and on a case by case basis], for African countries with unsustainable debt burdens, significant debt reduction and cancellation for heavily indebted non-HIPC African countries;
- e) Make efforts to fully integrate African countries in the international trading system, including through targeted capacity-building programmes for bilateral and multilateral trade negotiations;
- f) Support the efforts of commodity-dependent African countries to restructure, diversify and strengthen the competitiveness of their commodity sectors and decide to work towards market-based arrangements with the participation of the private sector for commodity price-risk management;
- g) Supplement the efforts of African countries, individually and collectively, to increase agricultural productivity, in a sustainable way, as set out in NEPAD's Comprehensive African Agricultural Development Plan, as part of an African "Green Revolution";
- h) Encourage and support the initiatives of the African Union and subregional organizations to prevent, mediate and resolve conflicts with the assistance of the United Nations, and in this regard welcome the proposals from the Group of Eight (G8) countries to provide support for African peacekeeping;
- i) Provide, with the aim of an AIDS-free generation in Africa, assistance for as close as possible to universal access by 2010 to HIV/AIDS prevention, care and treatment in African countries, as a priority. Encourage pharmaceutical companies to make drugs, including antiretroviral drugs, affordable and accessible in Africa and ensure increased support for bilateral and multilateral assistance to combat malaria, tuberculosis and other infectious diseases in Africa through strengthening health systems.

# III. Peace and collective security

- 55. We recognize that we are facing a whole range of threats that require our urgent, collective and more determined response.
- 56. We also recognize that, in accordance with the Charter, addressing such threats requires cooperation among all the principal organs of the United Nations within their respective mandates.

- 57. We acknowledge that we are living in an interdependent and global world and that many of today's threats recognize no national boundaries, are interlinked and must be tackled at the global, regional and national levels in accordance with the Charter and international law.
- 58. We therefore reaffirm our commitment to work towards a security consensus based on the recognition that many threats are interlinked, that development, peace, security and human rights are mutually reinforcing, that no State can best protect itself by acting entirely alone and that all States need an effective and efficient collective security system, pursuant to the purposes and principles of the Charter.
- 59. [We resolve to take concerted action, through such a system of collective security, based on the Charter and respect for international law, so as to prevent, mitigate and remove threats to international peace and security, respond effectively to natural disasters and ensure economic development and the full enjoyment of human rights for all States and peoples.]

# [Pacific settlement of disputes]

- 60. [We emphasize the obligation of States to settle their disputes by peaceful means in accordance with Chapter VI of the Charter, including, when appropriate, by the use of the International Court of Justice. All States should act consistent with the Declaration on Principles of International Law concerning Friendly Relations and Cooperation among States, in accordance with the Charter.]
- 61. We stress the importance of prevention of armed conflict in accordance with the purposes and principles of the Charter, and solemnly renew our commitment to promote a culture of prevention of armed conflict as a means of effectively addressing the interconnected security and development challenges faced by peoples throughout the world, as well as to strengthen the capacity of the United Nations for the prevention of armed conflict.
- 62. We further stress the importance of a coherent and integrated approach to the prevention of armed conflicts and the settlement of disputes, and the need for the Security Council, the General Assembly, the Economic and Social Council and the Secretary-General to coordinate their activities within their respective Charter mandates.
- 63. Recognizing the important role of the good offices of the Secretary-General, including in the mediation of disputes, we support the Secretary-General's efforts to strengthen his capacity in this area.

#### Use of force under the Charter

64. We reiterate [the obligation of all Member States] [the commitment] to refrain in their international relations from the threat or use of force in any manner inconsistent with the Charter of the United Nations. We reaffirm that one of the purposes and principles guiding the United Nations is to maintain international peace and security, and to develop friendly relations among nations based on the respect for the principles of equal rights and self-determination of peoples, and to take other appropriate measures to strengthen universal peace, and to that end we are determined to take effective collective measures for the prevention and removal of threats to the peace and for the suppression of acts of aggression or other breaches of the peace, and to bring about by peaceful means, in conformity with the

principles of justice and international law, the adjustment or settlement of international disputes or situations that might lead to a breach of the peace.

- 64 bis. [We reiterate the importance of promoting and strengthening the multilateral process, and addressing international challenges and problems by strictly abiding by the Charter and the principles of international law, and further stress our commitment to multilateralism. In this regard, we express our rejection of unilateralism, which is increasingly leading to the erosion and violation of international law, to the use and threat of use of force and to pressure and coercion in international relations.]
- 65. We also reaffirm that the relevant provisions of the Charter regarding the use of force are sufficient [to address the full range of threats to international peace and security] [and further affirm that the use of force should be considered an instrument of last resort.] We further reaffirm the [exclusive] authority of the Security Council to mandate coercive action to maintain and restore international peace and security. [We also stress the importance of acting in accordance with the purposes and principles of the Charter.] [We also stress the importance of the adherence to the principle of legality in the exercise of the functions of the Security Council, including acting in accordance with the purposes and principles of the Charter.]
- **65. bis.** We reaffirm that the Security Council has primary responsibility in the maintenance of international peace and security. We also note the role of the General Assembly relating to the maintenance of international peace and security in accordance with the relevant provisions of the Charter.
- 66. ter. [We are determined to enhance the consistent application of the principle of non-use of force in international relations.]
- 67. [We recognize the need to continue discussing [principles] [criteria for consideration] for the use of force, including those identified by the Secretary-General.]

#### Disarmament and non-proliferation

- {{The proposals which have been put forward have not generated consensus. This text lacks sufficient language on disarmament. Further proposals are needed to balance this text.}}
- [68. We believe that the proliferation of weapons of mass destruction and their means of delivery, and the possibility that terrorists might acquire such weapons, remain [amongst] the greatest threats to international peace and security.] [We reaffirm our pledge to strive for general and complete disarmament, including the elimination of all weapons of mass destruction.]
- [69. We urge all States Parties to the Treaty on the Non-Proliferation of Nuclear Weapons (NPT), Biological and Toxin Weapons Convention (BTWC) and Chemical Weapons Convention (CWC) to comply fully with their obligations under those treaties.]
- 70. We resolve therefore to:
- a) [Revitalize and enable, as appropriate, the Conference on Disarmament, the UN Disarmament Commission and the First Committee of the UN General Assembly to effectively address the existing and emerging challenges to regional and international security;]
- b) [Urge the Conference on Disarmament to agree on a programme of work;]

- c) [Improve the effectiveness and efficiency of International Atomic Energy Agency safeguards, and to this end call on all States Parties to the NPT that have not yet done so to conclude and implement relevant Safeguards Agreements and also Additional Protocols, the standard for verification;]
- d) [Support efforts by all prospective States parties and other interested countries [, in accordance with UN guidelines,] [, on a case-by-case basis,] towards the establishment of nuclear-weapon-free zones which contribute to restraining the spread of nuclear weapons;]
- e) [Take effective measures to establish domestic controls, in accordance with Security Council resolution 1540, to prevent the proliferation of nuclear, chemical, or biological weapons and their means of delivery to non-state actors, including through national adoption and enforcement of appropriate controls over related materials, and appropriate effective laws which prohibit non-state actors from gaining access to such weapons and their means of delivery;]
- f) Encourage States Parties to the Convention on the Physical Protection of Nuclear Material (CPPNM) to seek early ratification of the amendment adopted on 8 July 2005, and also encourage those States which have not already done so to promptly accede to the Convention and ratify its amendment;
- g) [Reconcile the right to peaceful uses of nuclear energy with compliance obligations under the NPT];
- h) [Strengthen the Biological and Toxin Weapons Convention (BTWC) through continued efforts to improve national implementation, and encourage all States Parties to submit information on confidence-building measures as required by the Review Conference of the BTWC;]
- i) [Complete the destruction of chemical weapons consistent with the Chemical Weapons Convention;]
- j) [We commit to improve the effectiveness of transfer controls over small arms and light weapons, including at the review conference of the UN Programme of Action, and recognize that development of international standards in arms transfers, including a common understanding of Governments' responsibilities, would be an important step towards tackling the undesirable proliferation of conventional weapons.]
- 71. We urge States parties to the Anti-Personnel Mine Ban Convention and Amended Protocol II to the Convention on Certain Conventional Weapons to fully implement their respective obligations. We also call upon States in a position to do so to provide greater technical assistance to mine-affected States.
- [72. We urge all States to support current international, regional and national efforts to combat and prevent the illicit transfer of man-portable air defense systems and unauthorized access to and use of such weapons.]

#### **Terrorism**

- 73. We strongly condemn terrorism in all its forms and manifestations, committed by whomever, wherever and for whatever purposes, as it constitutes one of the most serious threats to international peace and security. We affirm that the deliberate targeting and killing [by terrorists] of civilians [and other legally protected persons] [other persons protected under international law] [non combatants] cannot be justified or legitimized by any cause or grievance. We declare that any such action intended to cause death or serious bodily harm to civilians [other legally protected persons] [other persons protected under international law] [non combatants], when the purpose of such an act, by its nature or context, is to intimidate a population or to compel a Government or an international organization to carry out or to abstain from any act, cannot be justified on any grounds [and constitutes an act of terrorism].
- 73 bis. [We recognize the necessity to make a distinction between terrorism and the legitimate right of peoples under occupation to struggle for their independence and in defense of their right to self-determination.]
- Alt1) [We recognize the legitimate right of peoples under foreign occupation to struggle for their independence and in defense of their right to self-determination, but that there can be no justification for terrorism whatever pretext terrorists may use for their deeds or for using efforts to combat terrorism to deny these rights.]
- Alt2) [We recognize the legitimate right of peoples under foreign occupation to struggle for their independence and in defense of their right to self determination. We further recognize that there can be no justification for terrorism by whomever and wherever committed and that efforts to combat terrorism cannot be used to deny such rights.]
- Alt3) [The legitimate right of peoples to resist foreign occupation, exercised in compliance with international law, cannot be construed as terrorism.]
- Alt4) (New paragraph 76bis): [We recognize the legitimate right of peoples to resist foreign occupation, exercised in conformity with international law.]
- Alt 5) [A text could be placed within Values and Principles section.]
- Alt6) [The text could be deleted entirely.]
- 74. We welcome the Secretary-General's identification of elements of a counter-terrorism strategy. These elements should be considered and developed by the General Assembly without delay with a view to adopting and implementing a strategy to promote comprehensive, coordinated and consistent responses, at the national, regional and international level, to counter terrorism, [also taking into account the need to address underlying conditions that may be exploited by terrorists]. In this context, we commend the various initiatives to promote dialogue, tolerance and understanding amongst civilizations.
- 75. We stress the need to [reach an agreement on and] conclude a comprehensive convention on international terrorism, [including a legal definition of terrorist offences/acts,] during the sixtieth session of the General Assembly.

# [75bis. We acknowledge that the question of convening a high-level conference under the auspices of the United Nations to formulate an international response to terrorism in all its forms and manifestations could be considered.]

- 76. We recognize that international cooperation to fight terrorism must be conducted in conformity with international law, including the Charter and relevant international conventions and protocols. States must ensure that any measures taken to combat terrorism comply with their obligations under international law, in particular human rights law, refugee law and international humanitarian law.
- 77. We reiterate our call upon all States to refrain from **[perpetrating]**, financing, encouraging, providing training for or otherwise supporting terrorist activities and to take appropriate measures to ensure that their territories are not used for such activities.
- 78. We acknowledge the important role played by the United Nations in combating terrorism and also stress the vital contribution of regional and bilateral cooperation, particularly at the practical level of law enforcement cooperation and technical exchange.
- 79. We urge the international community, including the United Nations, to assist States in building national and regional capacity to combat terrorism. We invite the Secretary-General to submit proposals to the General Assembly and the Security Council, within their respective mandates, to strengthen the capacity of the United Nations system to assist States in combating terrorism and to enhance the coordination of United Nations activities in this regard.
- 80. We stress the importance of assisting victims of terrorism and of providing them and their families with support to cope with their loss and their grief.
- 81. We encourage the Security Council to consider ways to strengthen its monitoring and enforcement role in counter-terrorism, including by consolidating State reporting requirements, taking into account and respecting the different mandates of its counter-terrorism subsidiary bodies. We are committed to cooperating fully with the three competent subsidiary bodies in the fulfilment of their tasks, recognizing that many States continue to require assistance in implementing relevant Security Council resolutions.
- 82. We support efforts for the early entry into force of the International Convention for the Suppression of Acts of Nuclear Terrorism and strongly encourage States to consider becoming parties to it expeditiously and acceding without delay to the twelve other international conventions and protocols against terrorism and implementing them.

#### **Peacekeeping**

83. Recognizing that United Nations peacekeeping plays a vital role in helping parties to conflict end hostilities and commending the contribution of United Nations peacekeepers in that regard, noting improvements made in recent years in United Nations peacekeeping, including the deployment of integrated missions in complex situations, and stressing the need to mount operations with adequate capacity to counter hostilities and fulfil effectively their mandates, we urge further development of proposals for enhanced rapidly deployable capacities to reinforce peacekeeping operations in crises. We endorse the creation of an initial operating capability for a standing Police Capacity to provide coherent, effective and responsive start-up capability for the policing component of the UN peacekeeping missions and to assist existing missions through the provision of advice and expertise.

- 84. Recognizing the important contribution to peace and security by regional organizations as provided for under Chapter VIII of the UN Charter and the importance of forging predictable partnerships and arrangements between the United Nations and regional organizations, and noting in particular, given the special needs of Africa, the importance of a strong African Union, we:
- Support the efforts of the European Union and other regional entities to develop capacities such as for rapid deployment, standby and bridging arrangements;
- Support the development and implementation of a 10-year plan for capacity building with the African Union.
- 84. bis. We underscore the importance of the recommendations of the Secretary-General's Advisor on Sexual Exploitation and Abuse by UN Peacekeeping Personnel, and urge that those measures adopted in the relevant General Assembly resolutions based upon the recommendations mentioned above be fully implemented without delay.

# **Peacebuilding**

- 85. Emphasizing the need for a coordinated, coherent and integrated approach to post-conflict peacebuilding and reconciliation, with a view to achieving sustainable peace; and recognizing the need for a dedicated institutional mechanism to address the special need of countries emerging from conflict towards recovery, reintegration and reconstruction and to assist them in laying the foundation for sustainable development; and recognizing the vital role of the United Nations in that regard, we decide to establish a Peacebuilding Commission as an intergovernmental advisory body [under the direction of the Security Council.]
- 86. The main purpose of the Peacebuilding Commission is to bring together all relevant actors to marshal resources and to advise on and propose integrated strategies for post-conflict peacebuilding and recovery. It will do so in cooperation with national or transitional authorities, as possible, with a view to ensuring national ownership of the peacebuilding process. The Peacebuilding Commission should focus attention on the reconstruction and institution-building efforts necessary for recovery from conflict and support the development of integrated strategies in order to lay the foundation for sustainable development. In addition, it should provide recommendations and information to improve the coordination of all relevant actors within and outside the United Nations, develop best practices, help to ensure predictable financing for early recovery activities and extend the period of attention by the international community to post-conflict recovery. The Peacebuilding Commission should act in all matters on the basis of consensus of its members.

[86 bis alt 1. The Peacebuilding Commission will be a subsidiary organ of the General Assembly. The Commission's mandate, function and composition shall be established by the General Assembly.]

OR

[The following four paragraphs are linked proposals, constituting a new 86 bis and replacements for 87, 88, 89 and 97.]

[86 bis. alt 2. The Peacebuilding Commission will be created jointly by the General Assembly and the Security Council, by concurrent resolutions setting out the provisions contained in this document.]

[(replaces 88/89). The advice of the Peacebuilding Commission will be made available to the Security Council, the Economic and Social Council, the General Assembly and other relevant bodies. Action will be taken according to the relevant provisions of the Charter and the responsibilities of the bodies represented in the Peacebuilding Commission. Where the UNSC is mandating a peacekeeping operation, the Peacebuilding Commission should pay particular attention to advising the UNSC on the implications of its operation for reconstruction, while the Peacebuilding Commission's members should seek to ensure that there are adequate simultaneous preparations for economic and institutional recovery.]

[(replaces 87.) The Peacebuilding Commission will consider items on the Security Council agenda brought to it by that body. Any Member State of the UN in an exceptionally difficult circumstance, on the verge of lapsing into conflict, should be able to request the advice of the Peacebuilding Commission. The organizational committee of the Peacebuilding Commission should consider the relevance of the request.]

[(replaces 97). These arrangements will be kept under review. After five years, they could be renewed or revised by joint agreement of the General Assembly and the Security Council.]

OR

87. [The Peacebuilding Commission should consider matters on the agenda of the Security Council brought before it by that body. Any other country in an exceptionally difficult situation, on the verge of relapsing into conflict, should be able to request through [the Economic and Social Council] [the Security Council] [the General Assembly] the advice of the Peacebuilding Commission. The organizational committee of the Commission should consider the relevance of the request.]

88. The Peacebuilding Commission should make the outcome of its discussions and its advice and recommendations publicly available as UN documents to all relevant bodies and actors, including the international financial institutions.

89. [The Peacebuilding Commission should provide advice to such bodies as are actively seized of the issue, in accordance with the Charter. In the initial stages of conflict recovery, and for as long as the Security Council is actively seized of the situation, the Peacebuilding Commission should provide advice to that body. Thereafter, the Peacebuilding Commission should provide advice to the Economic and Social Council.]

89.alt. [The Peacebuilding Commission should provide advice on Peacebuilding strategies for countries emerging from conflict to such bodies as are seized of the issue, in accordance with the Charter. In the initial stages of conflict recovery, and for as long as the Security Council is seized with the situation, the Peacebuilding Commission should provide advice to that body. Thereafter, the Peacebuilding Commission should provide advice also to other UN bodies, as appropriate.]

- 90. The Peacebuilding Commission should submit an annual report to the General Assembly.
- 91. The Peacebuilding Commission should meet in various configurations. Country-specific meetings of the Commission upon invitation of the Organizational Committee should include as members, in addition to members of the Organizational Committee, representatives from:
- a) the country under consideration;
- b) countries in the region engaged in the post-conflict process, and other countries including neighbours that are involved in relief efforts and/or political dialogue, as well as relevant regional and sub-regional organizations;
- c) the major financial, troop and civilian police contributors involved in the recovery effort;
- d) the senior United Nations representative in the field and other relevant United Nations representatives;
- e) such regional and international financial institutions as may be relevant.
- 92. The Peacebuilding Commission should have a standing organizational committee, responsible for developing its procedures and organizational matters, comprised of:
- **a)** [Seven] members of the Security Council [including five permanent members and two non-permanent members];
- **b)** [Seven] members of the Economic and Social Council, elected from regional groups, giving due consideration to those countries that have experienced post-conflict recovery;
- c) [Five] [of the ten] top providers of assessed contributions to the United Nations budgets and voluntary contributions to the United Nations funds, programmes and agencies, including the Standing Fund for Peacebuilding not among those selected in (a) or (b), to be selected, according to procedures to be developed, from a list provided by the Secretary-General;
- **d)** [Five] [of the ten] top providers of military personnel and civilian police to United Nations missions, not among those selected in (a), (b) or (c) to be selected, according to procedures to be developed, from a list provided by the Secretary-General;
- e) [Three] members from the General Assembly that have experienced post-conflict recovery.
- 93. Representatives from the World Bank, the International Monetary Fund and other institutional donors should be invited to participate in all meetings of the Peacebuilding Commission in a manner suitable to their governing arrangements, in addition to a representative of the Secretary-General.
- 94. We request the Secretary-General to establish a multi-year standing Peacebuilding Fund for post-conflict peacebuilding, funded by voluntary contributions and taking due account of existing instruments. The objectives of the Peacebuilding Fund will include ensuring the immediate release of resources needed to launch peacebuilding activities and the availability of appropriate financing for recovery.
- 95. We request the Secretary-General to establish, within the Secretariat and from within existing resources, a small peacebuilding support office staffed by qualified experts to assist and support the Peacebuilding Commission. The office should draw on the best expertise available.

- 96. We request the President of the General Assembly to conduct consultations with Member States in order to develop the necessary modalities such that the body can begin operation no later than 31 December 2005.
- [96. alt. We request the General Assembly to hold negotiations in an open-ended working group in order to establish the modalities, functions, procedures, working methods and selection of the Chairs of the Peacebuilding Commission, so that the body can begin operations no later than 31 December 2005.]
- [97. The arrangements set out above will be kept under review with a view to ensuring that they are appropriate to delivering the agreed functions of the Peacebuilding Commission. Future proposals to change the arrangements hereby decided upon should be forwarded jointly by the Security Council and the Economic and Social Council to the General Assembly for its approval.]

#### **Sanctions**

- 98. We underscore that sanctions remain an important tool under the Charter in our efforts to maintain international peace and security without recourse to the use of force, and resolve to ensure that sanctions are carefully targeted in support of clear objectives, [subject to [time limits] [periodic review] where appropriate, and are implemented and monitored effectively with clear benchmarks and accountability] to comply with sanctions established by the Security Council and to ensure that sanctions are implemented in ways that [mitigate] [balance effectiveness to achieving the desired results against the possible] adverse consequences, including socio-economic and humanitarian consequences, for populations and third States.
- 98. bis. [We agree that sanctions should not be used as a prelude to the use of force and should be imposed only when other peaceful means have proved inadequate and have been exhausted. Termination of sanctions should be automatic in cases where either the objectives of the sanctions have been achieved or the situation on the ground that led to the imposition of the sanctions has itself changed. We also emphasize that sanctions should not be used for political motivations and reaffirm that no State should use or encourage the use of United Nations sanctions as well as unilateral economic, political, or any other measure to coerce another State in order to subordinate the exercise of its sovereign rights.]
- 99. We call upon the Security Council, with the support of the Secretary-General, to improve its monitoring of the implementation and effects of sanctions, to ensure that sanctions are implemented in an accountable manner, to review regularly the results of such monitoring and to develop a mechanism to address special economic problems arising from the application of sanctions in accordance with the Charter.
- 99. bis. [We also call upon the Security Council [and] OR [with the support of] the Secretary-General to ensure that fair and transparent procedures, in accordance with [international standards of due process] OR [international law], exist for placing individuals and entities on sanctions lists and for removing them, as well as for granting humanitarian exemptions.]
- 100. We support efforts through the United Nations to strengthen State capacity to implement sanctions provisions.

#### **Transnational crime**

- 101. We express our grave concern at the negative effects on development, peace and security and human rights posed by transnational crime, including the smuggling of and trafficking in human beings, the world narcotic drugs problem and illicit trade of small arms and light weapons, and at the increasing vulnerability of States to such crime. We reaffirm the need to work collectively to combat transnational crime.
- 102. We recognize that trafficking in persons continues to pose a serious challenge to humanity and requires a concerted international response. To that end, we urge all States to devise, enforce and strengthen effective measures to combat and eliminate all forms of trafficking in persons to counter the demand for trafficked victims and to protect the victims.
- 103. We urge all States that have not yet done so to consider becoming parties to the relevant international conventions on organized crime and corruption, and following their entry into force, for them to implement them effectively, including by incorporating the provisions of those conventions into national legislation and by strengthening criminal justice systems.

103bis. We reaffirm our unwavering determination and commitment to overcome the world narcotic drugs problem through international cooperation and national strategies to eliminate both the illicit supply of and the demand for illicit drugs.

104. We resolve to strengthen the capacity of the United Nations Office on Drugs and Crime within its existing mandate to provide assistance to Member States in those tasks upon request.

# Women in the prevention and resolution of conflicts

105. We stress the important role of women in the prevention and resolution of conflicts and in peacebuilding. We reaffirm our commitment to the full and effective implementation of Security Council resolution 1325 (2000) on women, peace and security. We also underline the importance of integrating a gender perspective and of women's opportunity for equal participation and full involvement in all efforts to maintain and promote peace and security, as well as the need to increase their role in decision-making at all levels. We strongly condemn all violations of the human rights of women and girls in situations of armed conflict and foreign occupation and the use of sexual exploitation, violence and abuse, and we commit ourselves to elaborating and implementing strategies to report on, prevent and punish gender-based violence.

#### Protecting children in situations of armed conflicts

106. We reaffirm our commitment to promote and protect the right and welfare of children in armed conflicts. We welcome the significant advances and innovations that have been achieved over the last several years. We welcome in particular the adoption of Security Council resolution 1612 (2005). We call upon States to consider ratifying and implementing the Optional Protocol to the Convention on the Rights of the Child on the Involvement of Children in Armed Conflict. We also call upon States to take effective measures, as appropriate, to prevent the recruitment and use of children in armed conflict, contrary to international law, by armed forces and groups, and to prohibit and criminalize such practices.

107. We therefore call upon all States concerned to take concrete measures to ensure accountability and compliance by those responsible for grave abuses against children. We

also reaffirm our commitment to ensure that children in armed conflicts receive timely and effective humanitarian assistance, including education, for their rehabilitation and reintegration into society.

# IV. Human rights and the rule of law

108. We recommit ourselves to actively protect and promote all human rights, the rule of law and democracy, and recognize that they are interlinked and mutually reinforcing and that they belong to universal and indivisible core values and principles of the United Nations, and call upon all parts of the United Nations to promote human rights and fundamental freedoms in accordance with their mandates.

108 bis. We reaffirm the solemn commitment of our States to fulfil their obligations to promote universal respect for, and observance and protection of all human rights and fundamental freedoms for all in accordance with the Charter, the Universal Declaration of Human Rights and other instruments relating to human rights and international law. The universal nature of these rights and freedoms is beyond question.

#### **Human rights**

109. We reaffirm that all human rights are universal, indivisible, interdependent and mutually reinforcing. While the significance of national and regional particularities and various historical cultural and religious backgrounds must be borne in mind, all States regardless of their political, economic and cultural systems have the duties to promote and protect all human rights and fundamental freedoms.

# [109 alt. We reaffirm the universality, indivisibility, and interdependence of all human rights and fundamental freedoms and that all human rights must be treated in a fair and equal manner, on the same footing, and with the same emphasis.]

- 110. We emphasize the responsibilities of all States, in conformity with the Charter, to respect human rights and fundamental freedoms for all, without distinction of any kind as to race, colour, sex, language, or religion, political or other opinion, national or social origin, property, birth or other status.
- 111. We resolve further to strengthen the United Nations human rights machinery with the aim of ensuring effective enjoyment by all of all human rights, civil, political, economic, social and cultural rights [including the right to development.]
- 112. We resolve to strengthen the Office of the United Nations High Commissioner for Human Rights, taking note of the High Commissioner's plan of action to enable it to effectively carry out its mandate to respond to the broad range of human rights challenges facing the international community, particularly in the areas of technical assistance and capacity building, through [the doubling of its regular budget resources] [at least a doubling of regular budget resources] [substantially increasing resources provided under the regular budget] over the next five years, with a view to progressively setting a balance between regular budget and voluntary contributions to its resources, [keeping in mind other priority programmes for developing countries] and the recruitment of highly competent staff, on a broad geographical basis and with gender balance, provided under the regular budget, and support its closer cooperation with all relevant United Nations bodies, including the General Assembly, the Economic and Social Council and the Security Council.

- 113. We resolve to improve the effectiveness of the human rights treaty bodies, including through more timely reporting, improved and streamlined reporting procedures [aimed at enabling the treaty bodies to function as a unified system [and additional resources, including for assistance to States to enhance their reporting capacities,]] [to be adopted by the States parties to the different instruments aimed at enabling the treaty bodies to better carry out their respective functions and additional resources, including for assistance to States to enhance their reporting capacities,] and to further enhance the implementation of their recommendations.
- 114. [We resolve to [integrate human rights into all areas of national policy and to] support the further mainstreaming of human rights throughout the United Nations system at all levels, including in decision-making, programming and planning of funds, programmes and agencies and support closer cooperation between the Office of the United Nations High Commissioner for Human Rights and all relevant United Nations bodies.]
- 115. We reaffirm our commitment to continue making progress in the advancement of the human rights of the world's indigenous peoples at the local, national, regional and international levels, including through consultation and collaboration with them, and to present for adoption a final draft United Nations Declaration on the Rights of Indigenous Peoples as soon as possible.
- 116. We recognize the need to pay special attention to the human rights of women and children and undertake to advance them in every possible way, including by bringing gender and child-protection perspectives into the human rights agenda.
- 117. We recognize the need for persons with disabilities to be guaranteed full enjoyment of their rights without discrimination. [We also affirm the need to finalize a comprehensive draft Convention on the rights of persons with disabilities to ensure enjoyment without discrimination.]
- 118: We note that the promotion and protection of the rights of persons belonging to national or ethnic, religious, and linguistic minorities contributes to political and social stability and peace and enriches the cultural diversity and heritage of society.
- 119. We support the promotion of human rights education and learning at all levels, including through the implementation of the World Programme for Human Rights Education, as appropriate and we encourage all States to develop initiatives in this regard.

# **Internally displaced persons**

120. We recognize the importance of the Guiding Principles on Internal Displacement as the **[minimum international standard] [essential framework]** for the protection of internally displaced persons and resolve to take effective measures to increase the protection of internally displaced persons.

#### Refugee protection and assistance

121. We commit ourselves to safeguard the principle of refugee protection and to uphold our responsibility in resolving the plight of refugees, through efforts aimed at addressing the causes of displacement, bringing about the safe and sustainable return of these populations, finding durable solutions for refugees in protracted situations and preventing refugee movement from becoming a

source of tension among States. We reaffirm the principle of solidarity and burden sharing and resolve to support nations in assisting refugee populations and their host communities.

#### Rule of law

- 122. Recognizing the need for universal adherence to and implementation of the rule of law at both the national and international levels, we:
- Reaffirm our commitment to the purposes and principles of the Charter and international law and to an international order based on the rule of law and international law, which is essential for peaceful coexistence and cooperation among States;
- Support the annual treaty event;
- Encourage Governments that have not yet done so to consider ratifying and implementing all treaties that relate to the protection of civilians;
- Call upon States to continue their efforts to eradicate policies and practices that discriminate against women and to adopt laws and promote practices that protect the rights of women and promote gender equality;
- [Support the establishment of a rule of law assistance unit within the Secretariat to strengthen United Nations activities to promote the rule of law and related human rights law through technical assistance and capacity building;]
- Recognize the important role of the International Court of Justice in adjudicating disputes among States, [call upon States that have not yet done so to consider recognizing the jurisdiction of the Court in accordance with its Statute and to make greater use of the Court's advisory opinions and agree to] consider means of strengthening the Court's work, including by supporting the Secretary-General's Trust Fund to Assist States in the Settlement of Disputes through the International Court of Justice on a voluntary basis.

#### **Democracy**

- 123. We reaffirm that democracy is a universal value based on the freely expressed will of people to determine their own political, economic, social and cultural systems and their full participation in all aspects of their lives. We also reaffirm that while democracies share common features, there is no single model of democracy, that it does not belong to any country or region, and reaffirm the necessity of due respect for sovereignty and the right for self-determination. We stress that democracy, development and respect for all human rights and fundamental freedoms are interdependent and mutually reinforcing. [We encourage the United Nations to continue to advance democratic principles and strengthen democratic institutions as a key component to supporting development, peacemaking, and building a more safe and secure world.]
- 124. We renew our commitment to support democracy by strengthening countries' capacities to implement the principles and practices of democracy and resolve to strengthen the capacity of the United Nations to assist Member States upon their request. We [welcome] [take note of] the establishment of a Democracy Fund at the United Nations and invite the Secretary-General to establish a [geographically balanced] advisory board to provide policy guidance [and to help ensure that practical arrangements for the Democracy Fund take proper account of existing UN activity in this field.]
- 125. [We support the Secretary-General's establishment of a United Nations Democracy Fund and invite Member States to give serious consideration to it.]

#### **Impunity**

126. [Recognizing that justice is a vital component of the rule of law, we commit ourselves to ending impunity for the most serious crimes of concern to the international community, such as crimes of genocide, crimes against humanity and war crimes, by cooperating with the International Criminal Court, the existing *ad hoc* and mixed criminal tribunals and other mechanisms for international justice, in accordance with international obligations undertaken by States' effective bilateral judicial cooperation, and the strengthening of national legal systems.]

[126 alt 1] Recognizing that justice is a vital component of the rule of law, we commit ourselves to ending impunity for the most serious violations of international humanitarian law: genocide, crimes against humanity and war crimes.]

[126 alt 2] [Recognizing that justice is a vital component of the rule of law, we agree that strengthening the national judicial systems is the most important means to end impunity for the most serious crimes of concern to the international community, such as crimes of genocide, crimes against humanity, and war crimes. We also commit to cooperate with the International Criminal Court, the existing ad hoc and mixed criminal tribunals and other mechanisms for international justice.]

# Responsibility to protect [civilian populations]

- 127. Each individual State has the responsibility to protect its populations from genocide, war crimes, ethnic cleansing and crimes against humanity. This responsibility to protect entails the prevention of such crimes, including their incitement, through appropriate and necessary means. We accept that responsibility and will act in accordance with it. The international community should, as appropriate, encourage and help States to exercise this responsibility and should support the United Nations to establish an early warning capability.
- 128. The international community, through the United Nations, also has the responsibility to use appropriate diplomatic, humanitarian and other peaceful means, in accordance with [Chapter VI and VIII of] the Charter, to help protect civilian populations from genocide, war crimes, ethnic cleansing and crimes against humanity. In this context, [we are prepared to take collective action] [we recognize our shared responsibility to take collective action], in a timely and decisive manner, through the Security Council, under [Chapter VII of] the Charter on a case by case basis and in cooperation with relevant regional organizations as appropriate, should peaceful means be inadequate and [national authorities fail to protect their populations [populations not be afforded protection]. We stress the need for the General Assembly to continue consideration of the responsibility to protect and its implications, bearing in mind the relevant provisions and principles of the Charter of the United Nations and international law [and the principle of non-interference in internal affairs of States]. [We note the importance of developing the capacity of States to exercise this responsibility and assist those which are under stress before crises and conflicts break out.]

[129. We invite the permanent members of the Security Council to refrain from using the veto in cases of genocide, war crimes, ethnic cleansing and crimes against humanity.]

130. We fully support the mission of the UN Special Advisor for the Prevention of Genocide.

# Children's rights

- 131. We express dismay at the increasing number of children involved in and affected by armed conflict, as well as all other forms of violence including domestic violence, sexual abuse and exploitation, and trafficking. We support cooperation policies aimed at strengthening the national capacities to improve the situation of those children and to assist in their rehabilitation and reintegration into society.
- 132. We commit ourselves to respecting and ensuring the rights of each child without discrimination of any kind, irrespective of the race, colour, sex, language, religion, political or other opinion, national, ethnic or social origin, property, disability, birth or other status of the child, his/her parent(s) or legal guardian(s).

#### **Human security**

- 133. [We stress the right of people to live in freedom and dignity. We commit ourselves to further discussion of the notion of human security in the General Assembly with a view to addressing more effectively the needs of vulnerable peoples.]
- [133 alt. We recognize that Human Security is a guiding principle to achieve a world where people can live in security and dignity, free from poverty and despair. Individuals are entitled to freedom from fear and freedom from want, with an equal opportunity to enjoy their rights and fully develop their human potential. And we commit ourselves to further discuss this principle in the General Assembly.]

# Culture of peace and initiatives on dialogue among cultures, civilizations and religions

- 134. We reaffirm the Declaration and Programme of Action on a Culture of Peace, as well as the Global Agenda for Dialogue among Civilizations and its Programme of Action, adopted by the General Assembly, and the value of different initiatives on dialogue among cultures and civilizations, including the dialogue on interfaith cooperation and the Alliance of Civilizations. We commit ourselves to taking action to promote a culture of peace and dialogue at the local, national, regional and international levels, and request the Secretary-General to explore enhancing implementation mechanisms and to follow up on those initiatives.
- 135. We underline that sports can foster peace and development and can contribute to an atmosphere of tolerance and understanding, and we encourage discussions in the General Assembly for proposals leading to a Sport and Development Plan of Action.

# V. Strengthening the United Nations

#### **General Assembly**

136. We reaffirm our commitment to strengthen the United Nations with a view to enhancing its authority and efficiency, as well as its capacity to address effectively, and in accordance with the purposes and principles of its Charter, the full range of challenges of our time. We are determined to reinvigorate the intergovernmental organs of the United Nations and to adapt them to the needs of the twenty-first century.

- 137. We stress that, in order to efficiently perform their respective mandates as provided under the Charter, United Nations bodies should not duplicate their work but should rather develop good cooperation and coordination in the common endeavour of building a more effective United Nations.
- 138. [We emphasize the need to provide the United Nations with sufficient and predictable resources with a view to enabling it to carry out its mandate in a fast-changing, complex and challenging world.]
- 139 alt. [In order to attract sufficient and predictable resources to fulfil its mission, a reformed United Nations must be responsive to its members, faithful to its founding principles, and adapted to carry out its mandate in a fast-changing and complex and challenging world.]

#### **Security Council**

- 140. We reaffirm that Member States have conferred on the Security Council primary responsibility for the maintenance of international peace and security, acting on their behalf, as provided by the Charter of the United Nations.
- 141. [We support comprehensive reform of the Security Council to make it more broadly representative, more efficient and more transparent in order to further enhance its effectiveness and the implementation of its decisions.]
- [We commit ourselves to take a decision on this vital issue no later than 31 December 2005.]
- [We request the General Assembly to review progress made on the reform set out above by 31 December 2005.]
- [Delete above two bullets.]
- 142. [We recommend that the Security Council adapt its working methods so as to increase the involvement of States not members of the Council in its work, enhance its accountability to the membership and increase the transparency of its work.]

#### **Economic and Social Council**

- We reaffirm the role that the Charter and the General Assembly have vested in the Economic and Social Council and recognize the need for a more effective Economic and Social Council, as a principal body for coordination, policy review, policy dialogue and recommendations on issues of economic and social development, as well as [for implementing the international development goals agreed at major summits and conferences] [for implementation of the international development goals agreed at major summits and conferences, including the Millennium Development Goals] [for promoting and reviewing the implementation of internationally agreed development goals, including those contained in the Millennium Declaration]. To achieve these objectives, the Council should perform the following functions:
- a) Promote global dialogue and partnership on global policies and trends in the economic, social, environmental and humanitarian fields. For this purpose, the Council will serve as a quality platform for high-level engagement among Member States and with the international financial institutions, the private sector and civil society, emerging global

- trends, policies and action as well as develop its ability to respond better and more rapidly to developments in the international economic, environmental and social fields;
- b) Hold a biennial high-level Development Cooperation Forum to review trends in international development cooperation, including strategies, policies and financing, promote greater coherence among the development activities of different development partners, and strengthen the links between the normative and operational work of the United Nations;
- c) [Monitor the compliance of all countries with and progress towards the implementation of the outcomes of major conferences and summits, including the internationally agreed development goals, and hold annual ministerial-level substantive reviews to assess progress, including a pilot process of voluntary peer reviews of progress, drawing on its functional and regional commissions, as well as other international institutions.] OR [Monitor all countries' progress towards the implementation of the outcomes of major conferences and summits, including the internationally agreed development goals, and hold annual ministerial-level substantive reviews to assess progress, drawing on its functional and regional commissions, as well as other international institutions, in accordance with their respective mandates;]
- d) Support and complement international efforts aimed at addressing humanitarian emergencies, including natural disasters, in order to promote an improved, coordinated response from the United Nations;
- e) Play a major role in the overall coordination of funds, programmes and agencies, ensuring coherence among them and avoiding duplication of mandates and activities;
- f) [[Focus on the linkage between peace and development. For this purpose, the Economic and Social Council will strengthen its work in post-conflict activities by: promoting long-term development in countries recovering from conflict, including working with the Peacebuilding Commission; reinforcing linkages between the Economic and Social Council and the Security Council on post-conflict management, building on the exercise of the advisory group on countries emerging from conflict; maintaining international attention and support, and enhancing system-wide inter-agency coordination in support of Governments during the long-term reconstruction, recovery, and reconciliation phase.]
- f) alt. [Focus on the linkage between peace and development. For this purpose, the Economic and Social Council will strengthen its work in post-conflict activities by promoting long-term development in countries recovering from conflict, including working with the Peacebuilding Commission, and reinforcing cooperation between the Economic and Social Council and the other main bodies of the United Nations on post-conflict related issues]
- 144. We stress that in order to fully perform the above functions, the organization of work, the agenda and the current methods of work of the Economic and Social Council should be adapted.

# **Human Rights Council**

145. Pursuant to our commitment to further strengthen the United Nations human rights machinery, we decide to establish a standing Human Rights Council as a [subsidiary organ of the General Assembly] [principal organ] to be based in Geneva, in replacement of the Commission

on Human Rights. [The General Assembly shall review and consider, within five years, [the functioning and effectiveness of the Council, including] whether the Council should be transformed into a principal organ.]

- 146. The Human Rights Council will be **[the organ primarily]** responsible for promoting universal respect for and observance and protection of all human rights and fundamental freedoms for all, without distinction of any kind and in a fair and equal manner, recognizing their universal, indivisible, inalienable and interrelated character and, *inter alia*, it will:
- a) Promote international cooperation to enhance the abilities of Member States to implement human rights commitments and international norms and standards, including through the provision of assistance by the Office of the United Nations High Commissioner for Human Rights to Member States, at their request, through programmes of education, advisory services, technical cooperation and capacity building;
- b) Serve as a forum for dialogue on thematic issues on all human rights and fundamental freedoms and make recommendations to the General Assembly for the further development of international law in the field of human rights;
- c) Promote effective coordination and the mainstreaming of human rights within the United Nations system, including by making policy recommendations [to the General Assembly, the Security Council, the Economic and Social Council and other United Nations bodies] [to other United Nations bodies as appropriate]. The Council should also work in close cooperation with regional organizations in the field of human rights;
- [d) Periodically review the compliance by all States with all their human rights commitments and obligations under international law, including the Charter and the Universal Declaration of Human Rights. This procedure will not duplicate the reporting procedures being carried out under the human rights treaties;]
- [e) Address any matters or situations related to the promotion and protection of human rights, including urgent or continuous human rights situations, make recommendations thereon to the Member States and provide policy recommendations to the United Nations system;]
- f) Assume and review the mandate, functions and special procedures of the Commission on Human Rights in order to preserve its strengths, as well as the arrangements and practices for NGO participation observed by the Commission on Human Rights under Article 71 of the Charter.
- 147. We request the President of the General Assembly to [conduct consultations with Member States] [conduct negotiations through a working group open to all Member States] [establish an open-ended working group open to all Member States] in order for the General Assembly to adopt during its sixtieth session, before [31 December 2005] [28 February 2006], the mandates, modalities, functions, procedures, size, composition and working methods of the Human Rights Council and arrangements for the transition from the Commission to the Council, based, *inter alia*, on the following considerations:

- a) [The Council shall comprise between 30 and 50 members] [The size of the Council should be comparable to the current membership of the Commission of Human Rights], each member serving for a period of three years, to be elected directly by the General Assembly by a [two-thirds] [simple] majority [and should not include any States subject to measures imposed under Article 41 or 42 of the UN Charter or the subject of a UN Security Council Commission of Inquiry or similar UN Security Council investigation of human rights violations]. In establishing the membership of the Council, due regard shall be given to the principle of equitable geographical distribution and the contribution of Member States to the promotion and protection of human rights;
- [(b) Those members elected to the Council should undertake to abide by human rights standards in their respect for and protection and promotion of human rights and will be evaluated during their term of membership under the review mechanism, unless they have been evaluated shortly before the start of their term in the Council;]
- [(b) alt Members elected to the Council shall undertake to abide by the highest human rights standards and to be reviewed under the review mechanism during their term of membership;]
- c) The Council shall submit an annual report to the General Assembly.

# **Secretariat and Management Reform**

148. [We recognize that in order to effectively comply with the principles and objectives of the Charter, we need an efficient and effective Secretariat which is accountable to the General Assembly on administrative and budgetary matters, and where relevant to all organs on all other matters. Its staff shall act in accordance with Article 100 of the Charter, in a culture of organizational accountability and integrity. Consequently:]

- i. We [welcome/recognize] the ongoing reform measures taken by the Secretary-General to strengthen accountability and oversight, to improve management performance and transparency, and to reinforce ethical conduct, and invite him to report to the General Assembly on the progress made in implementation;
- ii. We emphasize the importance of establishing effective and efficient mechanisms for responsibility and accountability of the Secretariat;
- iii. We urge the Secretary-General to ensure that the paramount consideration in the employment of the staff shall be the necessity of securing the highest standards of efficiency, competence, and integrity, with due regard paid to the importance of recruiting the staff on as wide [and equitable] a geographical basis as possible, [in particular in the senior and policy-making levels.]
- iv. We further call upon the Secretary-General to strongly promote gender balance in staffing the Secretariat, in particular at the senior levels, [recognizing the low proportion of women from developing countries.]
- v. We [welcome/recognize] the Secretary-General's efforts to ensure ethical conduct, more extensive financial disclosure for UN officials, and enhanced protection for those who reveal wrongdoing within the Organization. We urge the Secretary-General to scrupulously apply the existing standards of conduct and develop a system-wide code of ethics for all UN personnel. We also [note] his intention to create an Ethics Office with independent

- status within the Secretariat. We request the Secretary-General to submit details on the creation of an Ethics Office to the 60<sup>th</sup> General Assembly.
- vi. [We urge the Secretary-General to make the best use of resources in accordance with clear rules and procedures agreed by the General Assembly, in the interests of all Member States, by adopting the best management practices and effective use of information and communication technologies, with a view to increase efficiency and enhance organizational capacity, concentrating on those tasks that reflect the agreed priorities of the Organization.]
- vi. bis. [We pledge to ensure that the Organization is provided with resources commensurate with the mandated programs and activities including those in the economic, social, and developmental areas, to ensure their full and effective implementation. We stress the obligation of Member States to pay all assessed contributions in full, on time, and without conditions, in accordance with the Charter;]
- 149. [We recognize the role of the Secretary-General as the chief administrative officer of the Organization, in accordance with Article 97 of the UN Charter, and pledge that he shall have the authority and flexibility required to carry out his managerial responsibilities. Therefore, on the understanding that the Secretary-General will establish a reliable, transparent and effective system of accountability, including annual reporting to the General Assembly on decisions taken and results achieved, we agree to provide the Secretary-General with sufficient authority and flexibility to deploy posts and resources in order to ensure the most effective management of the United Nations and implementation of the Organization's mandates. We request the Secretary-General to propose the necessary amendments to relevant rules and regulations, along with a clear description of the system of accountability.]
- 149 alt. [We recognize the role of the Secretary-General as the chief administrative officer of the Organization in accordance with Article 97 of the UN Charter and call on the SG to fully utilize the authority given to him by the General Assembly. We request the Secretary-General to establish a reliable, transparent and effective system of accountability, including annual reporting to the General Assembly on decisions taken and results achieved. We request the Secretary-General to propose the necessary amendments to relevant rules and regulations, along with a clear description of the system of accountability.]
- 150. We commend the Secretary-General's previous and ongoing efforts to enhance the effective management of the United Nations and his commitment to update the Organization. [Bearing in mind our responsibility as Member States, we emphasize the need to decide on additional reforms in order to make more efficient use of the financial and human resources available to the Organization and thus better comply with its principles, objectives and mandates. We call on the Secretary-General to submit proposals for implementing management reforms to a plenary session of the General Assembly for consideration and decision in the first quarter of 2006, which will include the following elements:] OR [We further recognize the need for additional reforms in order to make more efficient use of the financial and human resources available to the Organization and thus better comply with its principles, objectives and mandates, which should include the following elements:]
- i) [The Secretary-General's assessment of the range of existing budgetary, financial and human resources rules, regulations and policies under which the Organization operates, with a view to updating and improving the effectiveness and efficiency of

the UN Secretariat, taking into account relevant General Assembly resolutions and ongoing review processes.]

#### OR

[We call on the Secretary-General to implement decisions of the General Assembly on human resources management reform. We recognize that the General Assembly at its 61<sup>st</sup> session will receive progress reports on human resources management and budgetary process reform. In this context, we request the SG to indicate for the decision of the GA any amendments to the relevant regulations and rules of the Organization that the reform efforts may require.]

ii) [A survey of all mandates, originating from existing resolutions of the General Assembly and other Organs [, older than five years,] which would be complementary to the existing periodic review of activities. This survey would take into account the Organization's functions and priorities and would include the Secretary-General's advice on and recommendations for programmatic changes and shifts in resources in order to strengthen and update the programme of work of the United Nations.]

#### OR

[We recognize the role of the relevant intergovernmental bodies in reviewing mandates and call on them to undertake such reviews on a continuous basis in order to strengthen and update the programme of work of the United Nations.]

- A detailed proposal on the framework for a one-time staff buy-out to improve personnel structure and quality, including an indication of costs involved and mechanisms to ensure that it achieves its intended purpose.
- iv: [Detailed proposals on the measures needed to establish within the Secretariat a reliable, transparent, and effective system of accountability and responsibility of the UN Secretariat for the decisions taken and the results achieved.]
- v. [Detailed proposals on additional authority and flexibility needed by the Secretary-General to redeploy posts and resources, in order to ensure the most effective implementation of the Organization's mandates, under relevant rules and regulations established by the General Assembly.]
- 151. [We recognize the need for an early conclusion of the consideration by the General Assembly of the Secretary General's proposals.]
- [152. We recognize the urgent need to substantially improve the Organization's oversight and management processes. We emphasize the need for the operational independence of OIOS. Therefore, we resolve to agree on and undertake the following measures:
  - a) The expertise, capacity and resources of OIOS on audit and investigations will be significantly strengthened as a matter of urgency;
  - b) We request the Secretary-General to submit an evaluation of the UN's entire auditing and oversight system, including the roles and responsibilities of management.

Recommendations arising from the evaluation should be considered by the 60<sup>th</sup> General Assembly;

- c) We agree on the need to provide the General Assembly with assessments on the work of OIOS and the external Board of Audit, identify possible gaps in the UN's oversight functioning, and provide independent recommendations to the General Assembly on resource and budget requirements of OIOS. We therefore agree to establish an independent oversight advisory committee of experts which would provide the General Assembly with better tools to exercise its governance responsibilities over the operations of the Organization. Members of the committee will be appointed by the General Assembly upon nomination by the Secretary-General. The 60<sup>th</sup> General Assembly will decide on the specific mandate of the committee, which should start functioning as of 2006:
- d) We authorize OIOS to provide internal oversight to United Nations agencies that request such services. This should only be done in such a way as to ensure that internal oversight services to the UN Secretariat will not be compromised.

[152 Alt: We recognize the role of the GA as the primary oversight body of the Organization. We emphasize the importance of ensuring the independence of the oversight structures of the Organization. Therefore, we recognize the need for the following measures:

- a) We urge the SG to conclude the comprehensive review of the governance arrangements and submit detailed proposals to the General Assembly to further strengthen the oversight structures;
- b) For OIOS to undertake a self-evaluation and submit proposals to the General Assembly aimed at strengthening its expertise and capacity, and of the feasibility of expanding its oversight services to the specialized agencies upon request.]
- 153. We insist on the highest standards of behaviour from all UN personnel and support the considerable efforts underway with respect to the implementation of the Secretary-General's policy of zero-tolerance regarding sexual exploitation and abuse by United Nations personnel, both at headquarters and in the field. We encourage the Secretary-General to submit proposals to the General Assembly leading to a comprehensive approach to victims' assistance by 31 December 2005.
- 154. We encourage the Secretary-General and all decision-making bodies to take further steps in mainstreaming a gender perspective in the policies and decisions of the Organization.
- 155. We strongly condemn all attacks against the safety and security of the personnel engaged in all United Nations activities. We call upon States to consider becoming party to the Convention on the Safety of United Nations and Associated Personnel and to conclude negotiations on a protocol expanding the scope of legal protection during the 60<sup>th</sup> session of the General Assembly.

#### **System-wide coherence**

156. We recognize that the United Nations brings together a unique wealth of expertise and resources on global issues. We commend the extensive experience and expertise of the various development-related organizations, agencies, funds and programmes of the United

Nations system in their diverse and complementary fields of activity and their important contributions to the achievement of [the Millennium Development Goals] [internationally agreed development goals] and the other development objectives established by various United Nations conferences.

157. We support stronger system-wide coherence by implementing the following measures:

#### **Policy**

- Strengthening linkages between the normative work of the United Nations system and its operational activities;
- Coordinating our representation on the governing boards of the various development and humanitarian agencies so as to ensure that they pursue a coherent policy in assigning mandates and allocating resources throughout the system;
- [Ensuring that the main horizontal policy themes, such as sustainable development, human rights and gender, are taken into account in decision-making throughout the United Nations];
- [[Committing to pledge funding in a more predictable manner] [Committing to pledge adequate core funding in a stable, sustainable, reliable and predictable manner].]

#### **Operational activities**

- Ensuring that at every stage of United Nations activities, the senior United Nations official present in any given country, whether special representative, resident coordinator or humanitarian coordinator, should have the authority and resources necessary to manage an integrated United Nations mission or country presence so that the Organization can truly function as one integrated entity;
- Implementing current reforms aimed at a more effective, efficient, coherent, coordinated and better-performing UN country presence with a strengthened role for the resident coordinator, with appropriate authority and accountability, and a common management, programming and monitoring framework;
- Inviting the Secretary-General to launch work to further strengthen the management and coordination of United Nations operational activities so that they can make an even more effective contribution to the achievement of [the Millennium Development Goals] [internationally agreed development goals], including proposals for more tightly managed entities in the field of development, humanitarian assistance and environment.

#### Humanitarian assistance

- Upholding and respecting humanitarian principles of humanity, independence, neutrality and impartiality and ensuring that humanitarian actors have safe and unimpeded access to vulnerable populations in need [in accordance with national law and international obligations];
- Facilitating more rapid humanitarian responses by improving the timeliness and predictability of humanitarian funding, in part by contributing to a revised and more

- rapidly actionable Central Emergency Revolving Fund and, accordingly, inviting Member States to contribute to the Fund;
- Supporting the efforts of the Secretary-General to strengthen inter-agency and country-level responses to the needs of internally displaced persons;
- Putting in place standby arrangements for personnel and equipment in order to ensure the capacity to respond immediately to major disasters and other emergencies;
- Strengthening Headquarters and field coordination structures and the leadership role of the United Nations resident and humanitarian coordinator and promoting monitoring response and accountability in close collaboration with Governments.

# [ [International environmental governance]

- Strengthening environmental standard-setting, scientific discussion and monitoring and treaty compliance by building on existing institutions, as well as the treaty bodies and the specialized agencies;
- Integrating environmental activities at the operational level in the broader sustainable development framework;
- Recognizing the need for a more coherent institutional framework of international environmental governance, with better coordination and monitoring, to initiate work to consider the possibility of a more integrated structure, as proposed by the Secretary-General, in particular for environmental standard-setting, scientific discussion, environment monitoring and assessment and providing broad policy advice and guidance, built on existing institutions.]

## **Regional organizations**

- 158. We support a stronger relationship between the United Nations and regional and subregional organizations, pursuant to Chapter VIII of the Charter, and therefore resolve to:
- a) Expand consultation and cooperation between the United Nations and regional and subregional organizations through formalized agreements between the respective secretariats, [and the regularized involvement of regional organizations in the work of the Security Council and the participation of relevant regional organizations in the Peacebuilding Commission, as appropriate];
- b) Ensure that regional organizations that have a capacity for the prevention of armed conflict or peacekeeping consider the option of placing such capacities in the framework of the United Nations Standby Arrangements System;
- c) Strengthen cooperation in the areas of economic, social and cultural fields;
- d) [Request the General Assembly, on an exceptional basis, to consider financing regional operations authorized by the Security Council with assessed contributions subject to rigorous accountability measures.]

#### Cooperation between the United Nations and parliaments

159. Recognizing the important role played by parliaments and generally by elected representatives, we call for closer cooperation between the United Nations and parliaments,

[including through the Inter-Parliamentary Union], with a view to furthering all aspects of the Millennium Declaration and ensuring the effective implementation of UN reform.

# Participation of non-governmental organizations, civil society and the private sector

- 160. We welcome the positive contribution of non-governmental organizations, civil society, local authorities and the private sector in the promotion and implementation of development and human rights programmes, stress the importance of their continued engagement with Governments, the United Nations and other international organizations in these key areas [and encourage responsible business practices such as those promoted by the Global Compact and innovative partnerships and alliances created by the United Nations Fund for International Partnerships in order to ensure the contribution of the private sector to the achievement of the Millennium Development Goals.]
- 161. We also welcome the dialogue between these organizations and Member States, as reflected in the first informal interactive hearings of the General Assembly with representatives of non-governmental organizations, civil society and the private sector.

#### **Charter of the United Nations**

- 162. Considering that the Trusteeship Council no longer meets and has no remaining functions, we should delete Chapter XIII of the Charter and references to the Council in Chapter XII.
- 163. [Reaffirming the irreversibility of the results of World War II] we [agree to] [should] eliminate references to "enemy States" in Articles 53, 77 and 107 of the Charter of the United Nations [with prospective effect.]
- 164. We request the Security Council to consider the composition, mandate and working methods of the Military Staff Committee and to submit a recommendation for further action to the General Assembly.
